Partnership Updates

The BHSCP is continuing to support multi-agency work via both virtual meetings and working.

The forthcoming Partnership Board meeting (8th June) has been postponed. We envisage that the Partnership Board meeting will go ahead on 28th September.



Covid 19 Measures: lead partners met fortnightly since early April to formulate and continue a city-wide approach to multi-agency/organisation work to deliver a joined-up response to the challenges we face in these unprecedented times. BHSCP lead partners identified a need to respond to the heightened risk to vulnerable children and families during Covid-19 lockdown periods, many of whom are now 'hidden' from professionals. This includes e.g. children whose usual protective factors such as attending school, being cared for by other relatives have been removed. Thank you for your efforts to promote a BHSCP safeguarding message **"If you see something... say something"** to encourage the public to report safeguarding concerns to the Front Door for Families.

We will continue to use this message over the summer and would be grateful if you could support us by continuing to share and promote this slogan.

Training Update

Our face to face training is currently suspended and it is unlikely that classroom-based training will resume until September at the earliest. Roll out of the Graded Care Profile 2 training tool to measure Neglect has also been delayed due to Covid 19. **However, we are looking to make this an e-learning offer as soon as possible.**

The BHSCP business team is looking at how we can work in this changing environment to continue to offer multi-agency training where feasible. The team is also signposting colleagues to local and national training and resources as well as providing on-line.
